




### Your responsibilities:

Supporting the design and implementation of international projects in the field of antimicrobial resistance, especially in partnership with Nigeria

- promote microbiological diagnostic stewardship in our partner countries, i.e. promote coordinated measures to improve the
  appropriate and timely use of microbiological diagnostics to guide therapeutic decisions, including sampling, identification and
  resistance testing of pathogens as well as reporting of results
- on-site mentorship on key laboratory processes and methods in clinical bacteriology as well as quality assurance, laboratory data management and analysis (e.g. use of WHONET)
- develop training materials and conduct trainings in partner countries
- specific activities include
  - o conduct practical training and mentorship of laboratory and clinical staff on site
  - o fulfill administrative tasks (reporting, budget control, logistics)
  - o work with an international and interdisciplinary team
  - o publish research results in collaboration with the International team
  - o continuously monitor activities and support corrective actions

### What we expect:

#### **Educational requirements**

- advanced higher education degree (university diploma, master's degree) in medicine, natural sciences or related field
- doctorate is desirable
- a postgraduate qualification with a focus on clinical microbiology is desirable

If you have foreign degrees and certificates, please document equivalence with a German qualification.

### Required skills and experience

- in clinical bacteriology
- in the field of diagnostic microbiology (especially culture-based bacteriology)
- in low- and middle-income countries, preferably in sub-Saharan
- in project management, especially of externally funded projects

#### Desirable skills and experience

- clinical work experience, preferably in the field of hygiene and infectious diseases
